- I. The meeting commenced at 11am with Dr K.Karunakaran in the chair.
- II. The Chairman welcomed the members of the Academic Council and stated the new regulations that is to implement Outcome Based Education and Choice Based Credit System.
- III. The Management Nominee, Dr.A.Ebenezer Jeyakumar (Director Academics) addressed the board and presented the objectives of the academic year 2016-17
- IV. The **new regulations** was moved by Dr.G.Senthil Kumar
- A. The following new regulations were proposed for the students admitted in Undergraduate and Post Graduate Programmes during the year 2016–2017 and onwards and the same was approved.
  1. The Semester Mark distribution of Continuous Internal Assessment is for 30% and Comprehensive Exam is for 70% except MBA and M.Com IB.
  2. The Semester Mark distribution of Continuous Internal Assessment is for 40% and Comprehensive Exam is for 60% for M.Com IB. The Continuous Internal Assessment is for 50% and Comprehensive Exam is for 50% for M.BA.
  3. The eligibility of attendance percentage for appearing the Comprehensive Examination is revised.

4. The Outcome Based Education system and Blooms Taxonomy evaluation method are introduced.
5. The Programme Educational Objectives (PEOs), Programme Outcomes (POs) and Course Outcomes (COs) were proposed.

6. The scheme of examination, the distribution of credits as well as marks for various courses were finalized.
7. The curriculum of every Programme is designed with total number of credits ranging from 140-150 for Undergraduate Programmes and 90-100 for Post Graduate Programmes.
8. The supplementary examinations will be conducted for maximum of two courses even in the history of arrears (either theory or practical course)

- B The following new regulations are proposed for the students admitted in Undergraduate Programmes during the year 2016–2017 and onwards and the same was approved.
1. i) Part IV - Basic Tamil course was approved as an Extra Credit Courses and is made compulsory who did not appear for Part I Tamil, and to the who have not studied Tamil for the students up to X/XII/Diploma
  - ii) Part IV - Advanced Tamil course was approved as an Extra Credit Courses and is made compulsory for the students who have studied Tamil up to XII Standard and taken other language under Part I

2. i) Job oriented courses are introduced as extra credit course in each semester, except in the sixth semester. There is no examination and the evaluation will be done by the panel of subject expert, staff in charge and the Head of the department.
- ii) Job oriented courses shall be assessed with credits and those who have completed the course, shall be mentioned as “Completed”.
3. A Special Interest Achievements component is added along with Extension and Extra-curricular activities (NCC, NSS, Sports, YRC) under Part V. Evaluation will be done by the panel of subject expert, staff in charge and the Head of the department.
4. Two Open Elective Course with 4 credits each, is introduced in the third and Fifth semesters.
5. Personality, Aptitude and Career Enhancement (PACE) is introduced in the semesters I, II, III, IV and V under Part IV, with the total credit of 7. Only Comprehensive Examination will be conducted for PACE and the passing minimum is 60%.The Question paper pattern for PACE is framed.
