- I. The meeting commenced at 11am with Dr K. Karunakaran in the chair.
- II. The Chairman welcomed the members of the Academic Council and stated the regulations of the academic year 2016 – 2017 which would be followed this year with few amendments.
- III. The Management Nominee, Dr.A.Ebenezer Jeyakumar (Director Academics) addressed the board and presented the objectives for the academic year 2017 - 2018
- IV. The **regulations and amendments (2017 – 2018)** was moved by **Dr.G.Senthil Kumar**

It is resolved to follow the same regulations of 2016 – 2017 with the following amendments for the students admitted in Undergraduate and Post Graduate Programmes during the year 2017-2018 and onwards and the same was approved.

The amendments were

1. Two credit papers with Maximum Marks of 50, if needed, can be introduced under Part III.
2. Duration of the Comprehensive Examination [CE] is reduced from 3 hours to 2 hours 30 minutes and also the time duration for Online CE is reduced from 60 minutes to 45 minutes. These are applicable to the students admitted during the year 2016 - 2017 and onwards.
3. In Undergraduate programmes, under Job Oriented Course - III students can undergo online certificate courses (minimum course duration 30 Hrs) conducted by recognized MOOC portal such as NPTEL, Swayam, Coursera and etc. Submission of certificate is mandatory for transferring credits into the curriculum.
In Postgraduate Programmes, under Open Elective (Interdisciplinary) Course students can select any one course offered by other departments or they are permitted to undertake any online course of their interest. Certification is mandatory.
4. The hours allotted for Open Elective Course is 4 hours per week and the credit concerned is 3. Comprehensive Examination for Open Elective Course “English for Competitive Examinations” (16BAEI01) and “General Studies for Competitive Examinations (16BMI02) will be conducted Online. The Question Paper carries 70 Multiple Choice Questions and each question carries one mark.

5. Students who opt for Industry Based Internship can take up the Final semester papers as 'self-study papers'. To avail Internship opportunity a good maintenance of attendance and academic record is necessary. Students are advised to produce a certificate from the authorities concerned.
6. Provision for withdrawal from the examinations
 - A candidate may be permitted to withdraw from any one of the semesters, except first semester, during the entire duration of the degree programme under valid and genuine reasons by making an application in the office of the Controller of Examinations through the respective HOD. The withdrawal application should reach the office of the Controller of Examinations at least one day in advance of the last theory examinations in that semester.
 - The withdrawn student can appear for Supplementary Examination and it will be considered as FIRST attempt as in the case of regular examinations
 - The candidates who withdraw are eligible for the award of First Class, First Class with Distinction and First Class – Exemplary as per the requirements, however he / she will not be considered for ranking.
 - Withdrawal is permitted only once in the whole programme.
 - Withdrawal is not permitted to the candidate who does not satisfy the attendance conditions prescribed in regulations as requirements for completion of a semester.
 - Withdrawal is not permitted to the candidate who rejoins the programme / transferred from other colleges.
7. The question paper pattern for the Accounts papers is changed in commerce stream.

8. Under the Twinning programme, a student can do a course or a semester in foreign universities. Credits earned at foreign universities will be converted accordingly and taken into account for CGPA calculations. Suitable approval from the regulatory authorities will be obtained.
9. Online Comprehensive (Section - A Multiple Choice Questions) Examinations are Conducted for PART - III & PART - IV Personality, Aptitude and Career Enhancement (PACE) courses only.
10. Distribution of Marks for Continuous Internal Assessment only theory Papers (No Comprehensive Examinations) - Value Education and Environment Studies in UG Courses has only Model Examinations Carries 80 Marks and Activity Caries 20 Marks.
